RESULTS OF THE RIGHTS AND EXCESS OFFERS

INTRODUCTION

Linked Unitholders are referred to the circular dated 15 December 2023 ("Circular"), relating to the renounceable rights offer ("Rights Offer") and excess offer ("Excess Offer") (collectively the "Capital Raising") of PrimeTime linked units ("Linked Units").

Capitalised terms used below and that are not otherwise defined, bear the meanings ascribed to them in the Circular.

The Company offered a total of 36 600 000 new Linked Units for subscription, by way of renounceable Rights, at the Rights Offer price of P1.75 per Linked Unit on the basis of the Ratio of Entitlement, being 145 Rights Offer Linked Units for every 1,000 Linked Units held by PrimeTime Unitholders who are permitted to participate in the Rights Offer and are reflected in the Linked Unit register of PrimeTime at the close of trade on the record date for the Rights Offer ("Qualifying Unitholders") to raise a maximum of P64 050 000 gross of expenses.

The Rights Offer was not underwritten.

The Company offered a total of 106 285 714 new Linked Units at the same price as the Rights Offer, being P1.75 per Linked Unit, to raise approximately P186 000 000 gross of expenses under the Excess Offer.

RESULTS OF THE CAPITAL RAISING

The Capital Raising closed at 16:00 on Friday, 02 February 2024, with subscriptions from Qualifying Unitholders allocated in full, as set out below:
