



NOTICE TO SHAREHOLDERS - UNCLAIMED DIVIDENDS

Access Bank Botswana (formerly BancABC Botswana) has consistently declared and paid dividends to its shareholders since it was listed on the Botswana Stock Exchange in late 2018. Dividend payments have previously been made either by cheque, and posted to shareholders' respective registered addresses, or directly into the bank accounts of those shareholders who have so instructed. Based on the information available to us, some of the dividend payments made remain unclaimed by the intended shareholders.

According to Section 5 of the Access Bank Botswana Dividend Policy, under subsection 5.5 entitled "Unclaimed Dividends":

"All dividends which are not claimed, shall be held by the Company for three years. The Company shall advertise for shareholders to claim the dividends due to them, on or about 31 December each year. Dividends unclaimed at the expiry of three years from the date of declaration of the dividend, may be appropriated by the Company."

Shareholders are therefore advised to come forward and claim their outstanding dividends by 31 May 2024, for all unclaimed dividends accrued on or before 31 December 2019, 31 December 2021, and 31 December 2022.
