

BASE PROSPECTUS SUPPLEMENT

This base prospectus supplement (the "**Base Prospectus Supplement**") is supplemental to and must be read in conjunction with the base prospectus dated 7 December 2023 relating to the £2,000,000,000 Euro Medium Term Note Programme (the "**Base Prospectus**") prepared by Investec plc (the "**Issuer**"). This Base Prospectus Supplement constitutes a supplementary prospectus for the purposes of Regulation (EU) 2017/1129 as it forms part of domestic law of the United Kingdom by virtue of the European Union (Withdrawal) Act 2018 (the "**UK Prospectus Regulation**") and section 87G of the Financial Services and Markets Act 2000.

Terms defined in the Base Prospectus shall have the same meaning when used in this Base Prospectus Supplement.

This Base Prospectus Supplement has been approved by the United Kingdom Financial Authority ("**FCA**"), as competent authority under the UK Prospectus Regulation. The FCA only approves this Base Prospectus Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer that is the subject of this Base Prospectus Supplement.

With effect from the date of this Base Prospectus Supplement the information appearing in, or incorporated by reference into, the Base Prospectus shall be supplemented in the manner described below.

The purpose of this Base Prospectus Supplement is to:

- disclose that on 28 June 2024 the Issuer published:
 - its annual report (including the auditor's report and audited consolidated annual financial statements) for the year ended 31 March 2024 (i.e the Investec plc silo annual report and accounts) (the "**2024 Annual Report**"). Any document incorporated by reference into the 2024 Annual Report shall not form part of this Base Prospectus Supplement; and
 - the group annual report - annual financial statements of the Investec Group's integrated annual report for the year ended 31 March 2024 containing combined financial statements of the Investec Group, the auditor's report, the unconsolidated balance sheet of Investec plc and shareholder information) for the year ended 31 March 2024 (the "**2024 Annual Financial Statements**"). The 2024 Annual Financial Statements are incorporated by reference herein. The 2024 Annual Financial Statements are available at <https://www.investec.com/content/dam/investor-relations/financial-information/group-financial-results/2024/Investec-Annual-financial-statements-Online-2024.pdf>. Any document incorporated by reference into the 2024 Annual Financial Statements shall not form part of this Base Prospectus Supplement; and
- amend the sub-section entitled "*Significant/Material Change*" of the "*General Information*" section of the Base Prospectus by replacing it in its entirety with the following:
 - "5. There has been no significant change in the financial position or financial performance of Investec plc and its subsidiary undertakings since 31 March 2024, being the end of the most recent financial period for which it has published financial statements.
 6. There has been no material adverse change in the prospects of Investec plc since the financial year ended 31 March 2024, the most recent financial year for which it has published audited financial statements."
