#### DIVIDEND PAYMENT AND REINVESTMENT THROUGH THE C-TRADE PLATFORM

Seed Co International Limited shareholders are advised that due to operational challenges related to payment of dividends **below USD10**, Seed Co International Limited hereby gives shareholders an option to receive their dividends through the C-TRADE platform.

C-TRADE is a mobile and online platform for the trading of securities on Zimbabwe's capital market and some of its benefits include;

- Access to full trading functionalities for the FINSEC and ZSE.
- An opportunity to accumulate small dividends and participate on ZSE & FINSEC anywhere at any time.
- Access to shareholder portfolio information.

#### Below is the simple process to access dividends on the C-TRADE platform

- ✓ Download the C-TRADE mobile App from Google Playstore or dial \*727# on your mobile phone. Alternatively visit [www.ctrade.co.zw](http://www.ctrade.co.zw) to access newly created C-TRADE account and view dividends paid out.
- ✓ Under 'My Profile' click PRE-CREATED ACCOUNT, enter Shareholder number (refer to your dividend advice slip) and complete in all missing details as requested.
- ✓ C-TRADE will activate the account, giving access to your C-TRADE portfolio to view your foreign currency dividend.
- ✓ To buy shares, enter the foreign currency amount you want to use and select 'CONVERT' to activate the process of conversion to ZWL currency.
- ✓ Once the conversion has been done through the bank, your ZWL wallets will be credited with the equivalent ZWL amounts and you will proceed to place an order.
- ✓ Alternatively, to withdraw your dividends from C-TRADE you will be required to convert to ZWL and withdraw the dividends through the C-TRADE normal withdrawal process.

Seed Co International shareholders with dividends **above USD10** have an option to have their dividends deposited in their C-TRADE accounts or to provide **local USD FCA Nostro Investment account** details or local RTGS account in order to receive their dividend. A bank mandate should be accompanied by a certified copy of national ID/Passport (for individuals) or CR14/Certificate of Incorporation and copies of Directors' ID/Passport (for corporates) to Corpserve Registrars.
